It explored the strategic evolution and growth trajectories of e-commerce logistics in India, offering in-depth insights into the sector’s rapid transformation. The report analyzed key trends, challenges, and opportunities that had shaped the logistics landscape, providing a valuable roadmap for stakeholders aiming to scale efficiently in a competitive and dynamic market.



BUSINESS SESSION 1

Unlocking India's Export Potential: Enhancing Global Competitiveness in the Current Geo-Economic Landscape

Business Session 1 focused on enhancing global competitiveness amid evolving geo-economic conditions. The discussion highlighted the need to build Brand India, empower SMEs and MSMEs, and streamline trade policies to boost export ease. The session also addressed pressing issues like the talent gap and cybersecurity threats in an increasingly digital supply chain.
